EIGHTY-NINTH REPORT OF THE LAW REFORM COMMITTEE OF SOUTH AUSTRALIA DEALING WITH THE INHERITED IMPERIAL LAW BETWEEN 1801 AND 1820

To:

The Honourable C. J. Sumner, M.L.C., Attorney-General for South Australia.

Sir,

This continues the reports on the inherited Imperial Law in South Australia and commences from the first statute of the Parliament of the United Kingdom of Great Britain and Ireland in 1801 and continues down to the year 1820.

States 41 Geo. III (1801) cc. 1-109:

Chapters 1-2 dealing with flour, 4 with unfunded debt, 5 a private Act, and 11 with mutiny, were all repealed in 1872. Chapter 3 dealing with the national debt was repealed in 1870. Chapter 6 dealing with militia was repealed by 49 Geo. III c. 120. Chapter 7 dealing with postage was repealed in 1837. Chapter 8 dealing with taxation was repealed in 1839. Chapters 9 dealing with horse duty, and 40, 69 and 71 dealing with taxation were all repealed by 43 Geo. III c.161. Chapter 10 dealing with taxation was repealed in 1861. Chapter 12 dealing with the sale of bread was repealed by 55 Geo. III c. xcix and 59 Geo. III c.36. Chapters 13 dealing with bounties, 14, 61 and 104 dealing with Wolfe Tone's rebellion, 15 with habeas corpus suspension, 16 with malt, 17 with taxation, 18 with marine mutiny, 19 with merchant shipping and 20 with commons improvement, were all repealed in 1872. Chapters 21 dealing with exports and 75 dealing with taxation were repealed by 6 Geo. IV c.105. Chapters 22 dealing with apprenticeship, 26 with habeas corpus suspension, 27 with lottery, and 28 and 29 with taxation, were repealed in 1872. Chapter 23 dealing with the poor law was repealed in 1967. Chapter 24 dealing with riots was repealed in 1887 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 25 dealing with the Master of the Rolls for Ireland was partly repealed by 4 Geo. IV c.61 and the balance by statutes of 1872 and 1950. Chapter 30 dealing with seditious meetings was repealed in 1872 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 31 dealing with barley, chapter 34 dealing with bounties, chapter 35 dealing with the quartering of soldiers, chapters 36 and 37 with exports, and chapter 41 with imports, were all repealed in 1872. Chapter 32 dealing with the Irish civil service was repealed by statutes from 1855-1971. Chapters 32, 42 and 62 relating to taxation, and 48 dealing with the sale of wine, were repealed in 1861. Chapter 38 dealing with combinations of workmen were repealed by 5 Geo. IV c.96. Chapter 39 dealing with forgery of bank notes was repealed in 1872 and is dealt with in the Fifty-Ninth Report of this Committee. Chapters 39 dealing with forgery of bank notes was repealed in 1872 and is dealt with in the Fifty-Ninth Report of this Committee. Chapters 43 dealing with militia pay, 44, 47 and 51 with taxation, 45 with acts continuance, 46 and 49 with an indemnity, and 54 dealing with the Isle of Man trade, were all repealed in 1872. Chapter 50 dealing with the Foundling Hospital in Dublin was repealed by 50 Geo. III c. cxcii. Chapter 52 dealing with House of Commons disqualification was partly repealed by statutes from 1888-1957 and is still partly in force. It applies, on the face of it, only to offices of profit under the Crown held in Great Britain and Ireland, and we do not think that we inherited it here. Chapter 53 dealing with damaging of hides was repealed by 5 Geo. IV c.57. Chapters 55 and 56

dealing with militia allowances, 58 with stamp duty, and 59 a personal Act, were repealed in 1872. Chapter 57 dealing with the forgery of bank notes was repealed by statutes from 1861-1981 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 60, a personal Act, was repealed in 1950. Chapter 63, the Clergy Disqualification Act 1801, is partly repealed by statutes from 1872-1965 and is partly still in force. Without doubt we inherited it here in 1857, but the matter is covered by section 44 of the Constitution Act 1935 and we do not think it necessary to retain the Imperial statute. Chapters 64 and 70 dealing with insolvent debtors' relief were repealed in 1872. Chapter 65 dealing with the national debt, 68 with imports, 74 with taxation, and 80 with an indemnity, were repealed in 1861. Chapters 66 dealing with indemnity, 67 with the Scottish militia, and 73 with Irish loans, were all repealed in 1872. Chapter 72 dealing with land tax redemption was repealed by 42 Geo. III c.116. Chapter 76 dealing with letters of Marque was repealed in 1864. Chapter 77 dealing with fisheries in Newfoundland was repealed in 1872. Chapter 78 dealing with the expenses of constables was repealed in 1964. The section is a sidenote to section 40 of our Police Offences Act 1936. That section was repealed by Act No. 54 of 1952 section 3 and nothing was put in its place, but we assume that the matter is now covered by regulation. If it is not, then the Imperial statute will require further consideration by you. Chapter 79 dealing with public notaries was amended by 3 & 4 Will. IV c.70 and by statutes of 1843-1893 and is still partly in force in England. It permits the Archbishop of Canterbury to grant faculties for the appointment of public notaries. The matter is completely covered by Part VII of the Legal Practitioners Act 1981 and is dealt with in the Sixty-First Report of this Committee. Chapters 81-83 dealing with loans on Exchequer bills, and 84 with appropriation, were repealed in 1872. Chapter 85 dealing with fines by Justices of the Peace was repealed by statutes of 1872-1950. It applies only to fines levied in England and we would not have inherited it here. Chapter 86 dealing with Probate duty was repealed by statutes from 1861-1975. Chapters 87 and 89 dealing with customs, 91 with excise, and 98 with militia pay, were repealed in 1861. Chapters 88 dealing with Judges' lodgings in Ireland is partly repealed by statutes from 1854-1888 and is still partly in force. Chapter 90 dealing with Crown debts as between England and Ireland was repealed by statutes from 1861-1982. Chapters 92 dealing with bounties, 93 with imports, 94 with customs, and 95 with trade with America, were all repealed in 1872. Chapter 96 dealing with prize was repealed in 1864. Chapters 97 and 99 dealing with sea fisheries were repealed in 1868. Chapters 100 dealing with Irish taxes, 101 with Irish elections, and 102 with pluralities of livings, a temporary Act on the subject, were all repealed in 1872. Chapter 103 dealing with Malta was partly repealed by statutes from 1872-1887. The King's Printer's index to the statutes gives the statute as still being in force, but that cannot be so as Malta obtained independence in 1964. The statute was either impliedly repealed by the Malta Independence Act 1964 or, it seems more probably, by a preceding Order in Council of 1930, but as we have not access to copies of Imperial Orders in Council we cannot check the point further. The statute in any case has no relevance in this country. Chapter 105 dealing with Scottish and Irish petitions to Parliament was repealed in 1972, chapter 106 dealing with imprisonment for debts abroad was repealed in 1872.

Chapter 107 dealing with copyright was repealed in 1842 and is dealt with in the Sixty-First Report of this Committee. Chapter 108 dealing with the forest laws was repealed in 1972. Chapter 109 dealing with enclosures was repealed in 1899. Accordingly of the statutes of 41 George III for 1801, chapters 1-5, 7-8, 10-11, 13-20, 22-24, 25 so far as unrepealed,

26-29, 31-37, 41-49, 51-52, 54-56, 58-68, 70, 73-74, 76-77, 78 but only after you have satisfied yourself on the point, 80-106 and 108-109 remain to be repealed in South Australia today.

Statutes 42 Geo. III (1801) cc. 1-16:

Chapters 1 dealing with malt duty, 2 with pension duty, 5 with brewing duty, 6 with a lottery, 7 and 16 with imports, and 9 with loans on Exchequer bills, were repealed in 1872. Chapter 3 dealing with fisheries was repealed in 1868. Chapter 8 dealing with the national debt was repealed in 1870. Chapter 10 dealing with prize, chapter 11 with foreign correspondence, 13 with corn, and 15 with distillation, were repealed in 1872. Chapter 14 dealing with starch was repealed in 1861. Accordingly all sixteen chapters of the statutes of 42 George III for 1801 should be repealed in South Australia today.

Statutes 42 Geo. III (1802) cc. 17-120:

Chapters 17 and 21 dealing with loans on Exchequer bills, 25 and 50 with mutiny, 26 and 51 with marine mutiny, 27 and 31 with taxation, 28 with transportation, 29 a local Act, 30 and 36 with pluralities, 35 with grain duty, and 36 with taxation, were all repealed in 1872. Chapters 18 and 22 dealing with the whale fishery, 44 with imports, 82 with smuggling, and 95 with customs, were all repealed by 6 Geo. IV c.105. Chapter 19 dealing with a fish market at Westminster, and chapter 79 dealing with sea fisheries, were repealed in 1868. Chapter 20 dealing with rum duty, chapter 24 with cinnamon duty, chapter 34 with window duty, chapter 37 with servant duty, chapter 38 with beer duty, chapter 43 with customs, and chapter 47 with sugar duty, were repealed in 1861. Chapter 23 dealing with an indemnity was repealed in 1871. Chapter 32 dealing with an embankment at Plymouth was repealed in 1898. Chapter 33 dealing with the national debt and chapters 58 and 99 dealing with stamp duty, were repealed in 1870. Chapters 39 dealing with loans, 40 and 45 with acts continuance, 41 with Exchequer bills, 42 with income tax repeal, 48 a personal Act, 49, 55 and 64-65 with militia pay, 52 with horse duties, 53 with an indemnity, and 54 with lotteries, were all repealed in 1872. Chapter 46 dealing with parish apprentices was repealed in 1927. Chapter 56 dealing with medicines was repealed in 1941. Chapter 57 dealing with the national debt commissioners, chapter 59 with bounties, chapter 60 with drawbacks, chapter 62 with oaths at polling places and elections, and chapter 69 with making returned soldiers free of trade restrictions, were all repealed in 1872. Chapters 61 dealing with Irish mariners, and 66 with yeomanry, were repealed in 1861. Chapters 63, 81 and 101 dealing with postage, were repealed in 1837. Chapter 67 dealing with theft was repealed in 1887 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 68 dealing with Irish yeomanry and chapter 72 dealing with the Stannaries militia, were both repealed in 1921. Chapter 70 dealing with the public accounts, chapters 71 and 112 with the national debt, 77 with Pacific fisheries, 93 with excise, 103 with Irish duties, and 117 with imports, were all repealed in 1861. Chapter 73 dealing with factories was repealed in 1878 and is dealt with in the Fifty-Eighth Report of this Committee. Chapters 74 dealing with workhouses, 75 with linen, and 76 with Metropolitan Police Magistrates, 80 with neutral ships, and 83 with coffee duties, were repealed in 1872. Chapter 84 dealing with controverted elections was repealed by 9 Geo. IV c.22. Chapter 85 dealing with the punishment of Governors and of other public employees in the colonies was partly repealed by statutes from 1911-1967 and is still partly in force. It is dealt with in the Fifty-Ninth Report of this Committee and as it is caught by the provisions of the Colonial Laws Validity Act it cannot be dealt with in this State until that Act has been repealed in its application to South Australia. Chapter 87

dealing with Parliament House Dublin is still in force but is obsolete. Chapters 88 dealing with mutiny, 92 with aliens, 96 with excise, 98 with Isle of Man trade, and 100 with horse duties, were repealed in 1872. Chapter 89 is a local Act. Chapter 90 dealing with militia was repealed by statutes from 1888-1980. Chapter 91 dealing with the Scottish militia was repealed by statutes from 1921-1980. Chapter 94 dealing with paper duties was repealed in 1839. Chapter 97 dealing with Clarke's hydrometer was repealed by 58 Geo. III c.28 and 6 Geo. IV c.105. Chapters 102 dealing with trade with Tortola, 104 with a lottery, 105 with the Lord Chancellor of Ireland, 106 with Irish elections, and 108 with quartering soldiers, were repealed in 1872. Chapter 107 dealing with deer stealing was repealed by 7 & 8 Geo. IV c.27. Chapter 109 dealing with Irish militia was repealed by 49 Geo. III c.120. Chapters 110 and 111 dealing with loans on Exchequer bills, 113 a personal Act, 114 with whale fishery, 115 with marine mutiny, 118 with Irish militia, and 120 with appropriation, were repealed in 1872. Chapter 116 dealing with land tax redemption was partly repealed by statutes from 1872-1963 and is still partly in force. Chapter 119 dealing with gaming was repealed in 1934. It was held to be in force in New South Wales in Attorney-General v. Edgley (1888) 9 L.R. N.S.W. 157, and is dealt with in the Sixty-Eighth Report of this Committee. Accordingly of the statutes of 42 George III for 1802, chapters 17, 19-20, 23-43, 45-66, 68-72, 74-77, 79-81, 83, 86-94, 96, 98-106, 108, 110-118 and 120 remain to be repealed in South Australia today.

Statutes 43 Geo. III (1802) cc. 1-17:

Chapters 1 dealing with notes, 3 with malt duties, 4 with pension duties, 5 with loans on Exchequer bills, 8 with baking and 9 with militia pay, were repealed in 1872. Chapters 2 dealing with the Irish militia and 7 with the navy, were repealed in 1861. Chapter 6 dealing with an indemnity was repealed in 1872. Chapter 10 dealing with exemption of religious teachers from service in the militia was repealed in 1921. Chapters 11 and 17 dealing with drawbacks, 12 and 13 with export, 14 with trade, and 16 with the navy, were repealed in 1872. Chapter 15 dealing with transportation was repealed by 5 Geo. IV c.84. Accordingly of the statutes of 43 George III for 1802, chapters 1-14 and 16-17 should be repealed in South Australia today.

Statutes 43 Geo. III (1803) cc. 18-162:

Chapter 18 dealing with the Bank of England was repealed by 59 Geo. III c.49. Chapter 19 dealing with the militia and 33 dealing with the Irish militia were repealed in 1861. Chapters 20 dealing with mutiny, 24 with taxation, 32 with whale fishery, and 34 with acts continuance, were repealed in 1872. Chapter 21 dealing with stamp duty and chapter 23 dealing with game duty were repealed by 52 Geo. III c.126. Chapter 22 dealing with hat duty was repealed by 51 Geo. III c.60. Chapter 25 dealing with Parliamentary elections in Ireland was repealed in 1868. Chapter 26 dealing with an annuity to the Prince of Wales and chapter 27 dealing with marine mutiny, were repealed in 1872. Chapter 28 dealing with postage was repealed in 1837. Chapter 29 dealing with acts continuance was repealed in 1868. Chapter 30 dealing with Roman Catholic relief was repealed in 1871. Chapter 31 dealing with woods and forests was repealed by 46 Geo. III c.142. Chapters 35, 65 and 66 are local Acts. Chapters 36 dealing with loans on Exchequer bills, 37 a personal Act, 38 with the militia, 39 with payments by the United States, 40 and 104 with Grenada and St. Vincent traders, and 41 with quartering soldiers, were all repealed in 1872. Chapters 42 and 43 dealing with revenue, 44 with the Bank of England, 49 and 52 with exports, and 53 with process in Ireland, were also repealed in 1872. Chapter 45 dealing with justices of the peace in Nottingham was repealed in 1874. Chapter 46 dealing with costs was repealed in 1890. It was held to be in force in New South

Wales in Bayless v. Dixon (1883) 4 L.R. (N.S.W.) 62 and is dealt with in the Fifty-Fifth Report of this Committee. Chapter 47 dealing with families of militiamen was repealed in 1875. Chapter 48 dealing with the East India Company and chapter 69 dealing with excise were both repealed in 1861. Chapters 50 and 100 dealing with the militia were repealed in 1921. Chapter 51 dealing with land tax redemption was repealed in 1896. Chapter 54 dealing with parochial schools in Scotland, and chapter 55 dealing with the defence of the Realm, were repealed in 1872. Chapter 56 dealing with passenger vessels was repealed by 4 Geo. IV c.84.

Chapter 57 dealing with trade during hostilities, chapter 60 with Exchequer bills, chapter 62 with the militia, chapter 63 with the East India Company, and chapter 64 with seamen, were repealed in 1872. Chapter 58 dealing with malicious wounding was repealed by 9 Geo. IV c.31. Chapter 59 dealing with bridges was repealed by statutes of 1959 and 1963. Chapter 61 dealing with returned soldiers and sailors was repealed in 1881. Chapters 67 dealing with the national debt, and 126 and 127 dealing with stamp duty, were repealed in 1870. Chapters 68 and 128 dealing with customs, and 153 with imposts, were repealed by 6 Geo. IV c.105. Chapter 70 dealing with customs, chapters 71 and 76 dealing with the militia, chapter 72 dealing with militia allowances, chapter 77 dealing with indemnity, and chapter 78 dealing with trade between Great Britain and Ireland, were repealed in 1872. Chapter 73 dealing with medicines was repealed in 1941. Chapter 74 dealing with oaths at Parliamentary elections was repealed in 1872. We do not think that this Act was ever received by us in South Australia. The oaths at elections were administered in the days before there was a secret ballot. Even if it was inherited by us in 1857, it would have been impliedly repealed by the Ballot Act of 1862. Chapter 75 dealing with the sale or mortgage of estates of lunatics was repealed by 11 Geo. IV & 1 Will. IV c.65. Chapter 79 dealing with wrecks was repealed by 9 Geo. IV c.53. Chapters 80 dealing with highways in Scotland, 81 with excise, 82, 83 and 85 with the defence of the Realm, and 91 with lotteries, were all repealed in 1872. Chapters 84 and 109 dealing with ecclesiastical benefices were repealed by 57 Geo. III c.99. Chapter 86 dealing with unlawful combinations in Ireland is obsolete. Chapter 87 dealing with negotiability of notes and bills was repealed by 45 Geo. III c.41. Chapter 92 imposing duties in Ireland was repealed in 1861. Chapter 93 dealing with loans on Exchequer bills, chapters 94 and 95 with militia pay, and 97 with revenue in Ireland, were all repealed in 1872. Chapters 96 and 120 dealing with the defence of the Realm were repealed by 46 Geo. III c.90. Chapter 98 dealing with the collection of revenue in Ireland was repealed in 1861. Chapter 99 is a Taxation Act which was repealed in 1880. It does however give the Crown additional process against defaulting collectors of taxes on behalf of the Crown and is regarded as important in that regard in Lynn: Execution on Crown Judgments (1932) at pages 129 and 134. We doubt whether it is necessary to keep this method of Crown process today but the matter should be referred to the Crown Law authorities before repealing the statute. Chapter 101 dealing with the defence of the Realm was repealed by 46 Geo. III c.144. Chapter 102 dealing with the Caledonian Canal was partly repealed by statutes of 1848 and 1872 and is partly in force. Chapters 103 dealing with customs, 105 with exports, and 110 with workhouses, were repealed in 1872. Chapter 106 dealing with loans for parsonages was repealed by 3 & 4 Will. IV c.37. Chapter 107 dealing with Queen Anne's Bounty was repealed in 1964. Chapter 108 dealing with gifts for churches was partly repealed by statutes from 1851 to 1960 and is partly in force in England. On the face of it it applies only to England and Ireland. The Tasmanian Church of England Act preserves this Act but we see no reason to do so here.

Chapter 111 dealing with friendly societies was repealed in 1857. Chapter 112 dealing with game was repealed by 1 & 2 Will. IV c.32. Chapter 113 dealing with the casting away of vessels was repealed in 1861 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 114 dealing with Treasury bills in Ireland, 115 with excise, 116 with habeas corpus suspension, and 117 with rebellion, were repealed in 1872. Chapter 118 dealing with the discovery of longitude at sea was repealed in 1861. Chapter 119 dealing with the relief of injured mariners was repealed by 10 Geo. IV c.26. Chapter 121 dealing with the yeomanry, 122 with income tax, 123 and 125 with defence of the Realm, and 133 with trade with Tortola, were repealed in 1872. Chapter 124 dealing with the defence of the realm in Scotland was repealed in 1861. Chapter 129 dealing with excise was repealed by statutes of 1872 and 1882. Chapter 130 dealing with auction duty, and chapter 131 dealing with customs, were repealed in 1861. Chapter 132 dealing with the warehousing of goods was repealed by 4 Geo. IV c.24. Chapter 134 dealing with prize goods was repealed in 1864. Chapter 135 dealing with Commissioners for a treaty with America, chapter 136 with wool, chapter 137 with the East India Company, and chapter 138 with Courts of justice in Canada, were repealed in 1872. Chapter 139 dealing with the forgery of foreign bills was partly repealed by 11 Geo. IV & 1 Will. IV c.66, partly by statutes of 1861 and 1888 and is still partly in force in England. It is dealt with in the Fifty-Ninth Report of this Committee. Chapter 140 dealing with habeas corpus is a Constitutional statute which will be dealt with by us in our report on Constitutional statutes. Chapter 141 dealing with protection to justices of the peace was amended by 9 Geo. IV c.29 and 11 Geo. IV & 1 Will. IV c.37 and by statutes from 1848 to 1888 and is still partly in force in England. It is dealt with in the Fifty-Eighth Report of this Committee. Chapter 142 dealing with the militia in Ireland was repealed by 49 Geo. III c.86. Chapter 143 dealing with public officers' protection in Ireland was repealed in 1980. Chapter 144 dealing with the poor law, chapter 145 with malt duty, chapters 146 and 147 with loans on Exchequer bills, 148 with Exchequer bills, and 149 with a grant to the House of Orange, were repealed in 1872. Chapter 150 dealing with taxation was repealed in 1880. Chapter 151 dealing with cotton manufacture was repealed by 5 Geo. IV c.96. Chapter 152 dealing with Dover pilotage, and chapter 158 dealing with glebe houses, were repealed in 1861. Chapter 154 dealing with duties, chapter 155 with aliens, chapter 156 with the purchase of the duties of prisage and butlerage of wines by the Treasury, chapter 157 with smuggling, and chapter 162 with appropriation, were repealed in 1872. Chapter 159 a personal Act was repealed in 1893. Chapter 160 dealing with prize and with Vice-Admiralty Courts in Malta, Bermuda and the Bahamas, was repealed in 1864. Chapter 161 dealing with house tax was repealed in 1924. Accordingly of the statutes of 43 George III for 1803, chapters 19-20, 24-30, 32-45, 47-55, 57, 59-67, 69-74, 76-78, 80-83, 85-86, 88-95, 97-98, 99 but only after the matters referred to in the report have been considered, 100, 102-105, 107-111, 113-188, 121-127, 129-131, 133-138, 143-152 and 154-162 remain to be repealed in South Australia today.

Statutes 44 Geo. III (1803) cc. 1-18:

Chapters 1 dealing with the Bank of England, 2 a personal Act, 3 with the East India Company, 4 with acts continuance, 5 and 10 with drawbacks, 8 with habeas corpus suspension, 9 with rebellion, 11 with distillation, 12 with exports, 14 with excise, 15 with loans on exchequer bills, 16 with malt duties, and 17 with pension duties, were all repealed in 1872. Chapter 6 dealing with negotiable bills in Ireland was repealed by 45 Geo. III c.41. Chapter 7 dealing with an indemnity was repealed in 1871. Chapter 13 dealing with Navy discipline was repealed in 1884. Chapter

18 dealing with the yeomanry was repealed in 1861. Accordingly of the statutes of 44 George III for 1803, chapters 1-5 and 7-18 need to be repealed in South Australia today.

Statutes 44 Geo. III (1804) cc. 19-110:

Chapter 43 deals with the ordination of clergy and is partly repealed by statutes of 1888 and 1964 and is partly still in force. It would appear to apply only to the Church of England and Church of Ireland. Chapters 44 dealing with Newfoundland trade, 49 with excise, and 58 with public accounts, were repealed in 1861. Chapters 45 and 46 dealing with loans on Exchequer bills, 50 and 51 with the militia, 53 with customs, 55 with excise, and 59 with an indemnity, were repelaed in 1872. Chapters 47, 48 and 99 dealing with the national debt were repealed in 1870. Chapter 52 dealing with highways was repealed by 5 & 6 Will. IV c.50. Chapter 84 dealing with postage was repealed in 1837. Chapter 86 dealing with fisheries was repealed in 1868. Chapter 87 dealing with masters and workmen was repealed by 6 Geo. IV c.96.

Chapters 103, 104 and 105 dealing with Irish revenue, 106 with public offices in Ireland, and 110 with appropriation, were repealed in 1872. Chapter 108 dealing with insolvent debtor's relief was repealed in 1872 and is dealt with in the Sixty-First Report of this Committee. Chapter 109 dealing with imports was repealed by 1 & 2 Geo. IV c.87. Accordingly of the statutes of 44 George III for 1804, chapters 19-33, 35-51, 53-55, 58-60, 61 so far as not already repealed, 62-65, 67, 70-73, 75-86, 89-90, 92 so far as not already repealed, 93-95, 97-99, 103-108 and 110 remain to be repealed in South Australian today.

We should add to what is said in the Sixty-First Report that part of the law relating to subpoenas of this kind was imported into our Act 15 of 1849 which in its turn was repealed by the Justices Act 1921, so that to that extent the recommendation in the Sixty-First Report should be modified. Chapter 94 dealing with hop duty, and chapter 97 with indemnity, were repealed in 1872. Chapters 43 dealing with wool, 44 with Sierra Leone, 45 a private Act, 46 with Windsor forest, 47 with calico duty, 48 with customs, and 49 with drawback, were repealed in 1872. Chapter 50 dealing with county infirmaries in Ireland is still in force. Chapters 51 and 67 dealing with British fisheries were repealed in 1868. Chapter 52 dealing with coffee duty, 55 and 57 with the militia, and 62 with drawbacks, were repealed in 1872. Chapters 53 dealing with the post office, 56 with the militia, 63 with excise, and 65 with auction duty, were repealed in 1861. Chapter 54 dealing with the possession of arms in Ireland was repealed in 1842. Chapter 59 dealing with the post office was repealed in 1837. Chapters 60 and 70 are local Acts. Chapter 68 dealing with the Government of India was repealed in 1890. Chapter 69 a private Act was repealed in

1950. Chapter 71 dealing with the militia was repealed by 56 Geo. III c.64. Chapters 72 dealing with Treasury bills in Ireland, 73 with loans on Exchequer bills, and 76 with appropriation, were repealed in 1872. Chapter 74 dealing with traders' debts was repealed by 11 Geo. IV & 1 Will. IV c.47. Chapter 75 dealing with benefices was repealed by 48 Geo. III c.5. Chapters 77 and 78 are private Acts. Therefore of the statutes of 47 George III sess. 2, chapters 1-4, 6-7, 9-11, 14-16, 18-23, 24 only after it has been dealt with as recommended in this report, 25-26, 28-38, 40 after it has been considered by you, 41, 43-57, 59-60, 62-63, 65, 67-70, 72-73 and 76-78 remain to be repealed in South Australia today.

Chapters 38, 76 and 83 dealing with the national debt were repealed in 1870. Chapter 40 dealing with an indemnity was repealed in 1871. Chapter 42 dealing with assessed taxes was repealed by 56 Geo. III c.57. Chapters 45, 46 and 51 and 52 dealing with the militia were repealed in 1872. Chapter 47 dealing with limitation of actions in Ireland was repealed in 1958. Chapter 48 dealing with the Dublin General Post Office is still in force. Chapters 49 dealing with the Paymaster-General, 50 with the granting of offices, and 53 and 54 with Exchequer bills, were repealed in 1872. Chapter 55 dealing with a house tax was repealed in 1924. Chapters 56, 57 and 62 dealing with the customs, 64 with the militia, 68 with bounty, 74 and 78 with malt duties, were repealed in 1861. Chapter 58 dealing with bail bonds was repealed in 1938 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 59 a personal Act, 60 dealing with tanners, 61 with the Army, 67 with customs, and 69 with exports, were repealed in 1872. Chapter 63 dealing with auction duty was repealed by 54 Geo. III c.82. Chapter 65 dealing with Church buildings in Ireland was repealed by 3 & 4 Will. IV c.37. Chapter 66 dealing with benefices in Ireland was repealed by 5 Geo. IV c.91. Chapter 70 dealing with ships captured by the enemy was repealed by 4 Geo. IV c.41. Chapter 71 an amendment of chapters 26 and 28 of this session dealing with customs, was repealed in 1872. Chapter 72 dealing with forests was partly repealed by statutes from 1961-1979 and is partly in force. Chapter 73 dealing with Crown lands was partly repealed by 10 Geo. IV c.50 and is partly in force. Chapter 75 dealing with the burial of drowned persons was repealed in 1948. The Tasmanian Act relating to the Church of England regards it as one which ought to be kept in force in Tasmania.

On the face of it it applies only in England and we see no reason why it should be kept in force here. Chapter 77 dealing with Londonderry schools was repealed in 1874. Chapter 79 dealing with malt duties in Ireland, 80 with customs in Ireland, and 85 with trade with America, were repealed in 1872. Chapter 81 dealing with spirit duty was repealed by 1 & 2 Will. IV c.55. Chapter 82 dealing with excise in Ireland was repealed by 59 Geo. III c.107. Chapter 86 dealing with fisheries was repealed in 1868. Chapter 87 dealing with hackney coaches was repealed by 1 & 2 Will. IV c.22. Chapter 88 dealing with bills of exchange was repealed in 1882. Chapters 91 dealing with the West Indies, 99 with prize, 107 with defence of the realm, 117 with silk duty, 119 with spirit duty, 120-121 with coffee, and 122 dealing with the Army, were repealed in 1861. Chapter 93 dealing with game was repealed by 1 & 2 Will. IV c.32. Chapter 96 dealing with lunatic paupers was repealed by 9 Geo. IV c.40. Chapter 100 dealing with prize was repealed in 1864. Chapters 101, 103, 113 and 137 are local Acts. Chapter 104 dealing with pilots was repealed by 52 Geo. III c.39. Chapters 105 dealing with trade with the Cape of Good Hope and 108 a private Act were repealed in 1872. Chapter 106, the Acts of Parliament Expiration Act, is without doubt in force in South Australia. It deals with the case of Acts of Parliament which expire whilst bills to continue the Acts are still pending in Parliament. It should be kept in force in South Australia but a section to that effect should be put in the Acts Interpretation Act where one would expect to find it. Chapter 110 dealing with herring fishery in Scotland was partly repealed by statutes from 1851-1981 and is partly in force. Chapter 111 dealing with a local militia was repealed by 52 Geo. III c.38. Chapters 112 dealing with Treasury bills in Ireland, 114 dealing with Exchequer bills, 115 and 118 with spirit duty, 126 with exports, and 131 with wool, were repealed in 1872. Chapter 123 dealing with imprisoned debtors was repealed in 1869 and is dealt with in the Sixty-First Report of this Committee. Chapter 125 dealing with imports was repealed by 3 Geo. IV c.44. Chapter 127 dealing with the confirmation of marriages celebrated in chapels was repealed by statutes from 1888-1960 and is partly in force. Chapter 128 dealing with regimental accounts was partly repealed by statutes from 1872-1964 and is partly in force. Chapter 129 dealing with larceny was repealed in 1861 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 130 dealing with frauds by boatmen in the Cinque Ports was repealed in 1854. Chapter 132 dealing with reprisals against foreign ships was repealed in 1864. Chapter 133 dealing with execution of Acts of that session, and chapter 134 dealing with hops, were repealed in 1872. Chapter 135 dealing with Grenada and St. Vincent traders was repealed in 1950. Chapter 136 dealing with the militia of the Tower Hamlets was repealed in 1872. Chapter 138 dealing with Teinds in the Church of Scotland was partly repealed by statutes from 1872-1888 and is partly in force. Chapter 139 dealing with lotteries and chapter 143 with licence duties were repealed in 1872. Chapter 140 dealing with Dublin Police Magistrates was partly repealed in 1971 and is partly in force. Chapter 141 dealing with assessment of taxes and their recovery appears to apply only in England. It was repealed in England in 1945. It is dealt with in Lynn at page 135 but we do not think it needs any attention here. Chapter 142 dealing with life annuities was partly repealed by statutes from 1872-1929 and is partly in force. Chapter 144 dealing with oyster fisheries was repealed in 1873. chapter 145 dealing with Judges' pensions in Scotland was repealed in 1981. Chapters 146 dealing with public buildings in Scotland, 147 dealing with the sale of a ship

taken in prize, and 148 dealing with appropriation, were repealed in 1872. Chapter 149 dealing with probate and legacy duties was repealed by statutes from 1870-1975 and is partly in force. As we have said previously, these Acts do have a bearing on our Succession Duty legislation, but we do not think it is necessary to preserve any part of this statute. Chapter 150 dealing with the Scottish militia was repealed by 52 Geo. III c.68. Chapter 151 dealing with the Court of Session in Scotland was partly repealed by statutes from 1872-1933 and is partly in force. Chapter 152 dealing with brewing duties was repealed in 1872. Bribery is dealt with in a general way in our Electoral Act but the special forms of bribery herein referred to may not be covered and it should go to you for consideration. Chapter 119 dealing with administration of justice in Scotland was repealed in 1872. Chapter 120 dealing with militia in Ireland was partly repealed by statutes from 1888 to 1975 and is partly in force. Chapter 121 dealing with bankrupts was no doubt received by us in 1836. It was repealed in 1861 and the subject is now dealt with by the Commonwealth Bankruptcy Act 1966. Chapter 122 dealing with frauds by boatmen was repealed in 1846. Chapter 123 dealing with prize money was repealed in 1864. Chapter 124 dealing with the poor law was repealed in 1927. Chapter 125 dealing with friendly societies was repealed in 1885 and is dealt with in the Sixty-First Report of this Committee. Chapter 126 dealing with sale of offices was partly repealed by statutes from 1872 to 1967 and is partly still in force. It is dealt with in the Fifty-Ninth Report of this Committee and cannot be further dealt with until the Colonial Laws Validity Act ceases to apply to South Australia. Chapter 127 dealing with salary of the Chief Baron of the Exchequer was repealed in 1861. Chapter 128 dealing with appropriation was repealed in 1872. Accordingly of the statutes of 1809, chapters 1-5, 7-15, 18-21, 23-34, 36-39, 42-44, 46, 49, 51-52, 54-58, 60, 63-64, 66-74, 76, 78-81, 83-85, 87-90, 92-97, 99, 101-102, 104-106, 109-112, 114-117, 118 but not until after reference to you, 119-124 and 127-128 remain to be repealed in South Australia today.

Chapters 151 dealing with the registrar in Admiralty and Prize, 152 with Westminster election, and 157 a personal Act, were repealed in 1873. Chapter 153 dealing with Judges' pensions was repealed in 1923 and is dealt with in the Sixty-First Report of this Committee. Chapter 154 dealing with Kilmainham Hospital was partly repealed by statutes from 1873 to 1875 and is partly in force. Chapter 155 dealing with the East India Company was repealed in 1915. Chapter 156 dealing with annuities was repealed in 1861. Chapter 158 dealing with Windsor Forest was partly repealed by statutes of 1961 and 1971 and is partly in force. Chapter 159 dealing with shipping was repealed in 1854. Chapter 160 dealing with the doctrine of the Trinity was repealed in 1873 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 161 dealing with exchequer bills was repealed in 1873. Chapters 1, 11, 17 and 20 dealing with the militia, 12 with the Army, 21 with salt duty, and 32 with distillation, were repealed in 1861. Chapters 2 dealing with malt duty, 6 with Acts continuance, 7 with export, 9 with distillation, 10 and 19 with the militia, 13 with aid to Russia, and 18 with the exchequer bills, were repealed in 1873. Chapters 3 and 8 relating to the national debt were repealed in 1870. Statutes 54 Geo. III (1814) cc. 44-190:

Chapters 44 and 54 dealing with Acts continuance, 47 with coffee, and 49 with trade with the West Indies, were repealed in 1873. Chapters 45, 62, 63, 113, 128, 138 and 154 are local Acts. Chapters 46 dealing with writs of assistance, 103 and 122 dealing with customs, 129 with imports, and 185 dealing with exports, were repealed by 6 Geo. IV c.105. Chapter 48 dealing with trade with West Indies was repealed by 3 Geo. IV c.44. Chapters 50, 64, 65, 66, 69 and 77 dealing with the customs, were repealed in 1861. Chapters 51 dealing with imports, 52 with gold, 53 with exchequer bills, and 55 with quartering soldiers, were repealed in 1873. Chapter 56 dealing with copyright in sculpture was repealed in 1911 but there may be sculptures prior to that date in South Australia which still have copyright under the older Act. It should be repealed but with a preservation of any rights still existing under the 1814 Act. Chapter 59 dealing with the slave trade was repealed in 1861 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 61 dealing with leave of a Governor or other public officer from a colony was repealed in 1894. Normally we would not be able to deal with this Act because it is obviously an Act applying within Her Majesty's Dominions, but in fact it was repealed by an Act of 1894, 57 and 58 Vict. c.17, which in the schedule expressly mentions South Australia. Chapters 76, 85, 89, 139 and 140 dealing with the national debt were repealed in 1870. Chapter 82 dealing with auction duties was repealed in 1845. Chapter 84 dealing with Michaelmas Quarter Sessions was repealed in 1845. Chapter 86 dealing with Army prize money was repealed by 2 and 3 Will. IV c.53. Chapter 87 dealing with glass duties was repealed by 55 Geo. IV c.7. Chapter 88 dealing with spirit duty and chapter 97 dealing with glass duty were repealed in 1861. Chapter 90 dealing with bridges was repealed by statutes of 1959 and 1963. Chapter 91 dealing with the poor law was repealed by statutes from 1925 to 1927. Chapter 92 dealing with probate and legacy duties in Ireland appears to be still in force there. Chapter 93 dealing with Navy prize money was repealed in 1864. Chapter 94 dealing with annuities to retired judges in Scotland, 98 with public accounts, 99 with Acts continuance, and 100 with exports, were repealed in 1873. Chapter 95 dealing with Judges' pensions in Ireland was repealed in 1950. Chapter 96 dealing with apprentices was partly repealed by statutes of 1873 and 1888 and is partly still in force. It is dealt with in the Fifty-Eighth Report of this Committee. Chapter 101 dealing with child stealing was repealed by 9 Geo. IV c.31. Chapter 102 dealing with the white herring fishery was repealed in 1868. Chapter 104 dealing with military roads in Scotland was repealed by 59 Geo. III c.135. Chapters 105 dealing with taxes in British India, 107 with apprentices, and 108 with shrouds, were repealed in 1873. Chapters 106 and 153 dealing with the drawback on paper were repealed in 1839. Chapter 109 dealing with highways was repealed by 5 and 6 Will. IV c.50. Chapter 110 dealing with Greenwich Hospital was repealed by 10 Geo. IV c.26. Chapters 111 dealing with imports, 112 with hospitals in Ireland, 114 with insolvent debtors, 115 with burning off land in Ireland, 127 with exports, 130 with the Bank of Ireland, and 132 with house duty in Ireland were repealed in 1873. Chapter 116 dealing with the recovery of wages in Ireland was repealed in 1850. Chapter 117 dealing with Church building in Ireland was repealed in 1851. Chapter 118 dealing with stamp duty in Ireland was repealed by 55 Geo. III c.81. Chapters 119 and 169 dealing with postage were repealed in 1837. Chapters 120 and 121 dealing with customs, 124 and 125 dealing with imports, and 142 with exports, were repealed in 1861. Chapter 123 dealing with the hop trade was partly repealed by statutes from 1866 to 1873 and 1979. Chapter 126 dealing with the relief of shipwrecked mariners was repealed by 6 Geo. IV c.87. Chapter 131 dealing with magistrates in Ireland was partly repealed by 6 and 7 Will. IV c.13 and the balance in 1851. Chapter 133 dealing with stamp duty on insurance policies was repealed in 1867.

Chapter 134 dealing with the East Indies trade, 135 with highways in Ireland, 149 with spirit trade, 152 with gun powder, 157 with the office of works, and 158 with Acts continuance, were repealed in 1873. Chapter 136 dealing with the Northern Lighthouse Commissioners was repealed in 1854. Chapter 137 dealing with the payment of creditors in Scotland was repealed in 1856. Chapter 141 dealing with duties on killing game was repealed in 1869. Chapter 143 dealing with Isle of Man harbours was repealed in 1872. Chapter 144 dealing with stamp duty was repealed in 1870. Chapter 145 dealing with corruption of blood on attainder was repealed in 1960 and is dealt with in the Sixty-Fifth Report of this Committee. Chapter 146 dealing with treason was partly repealed by statutes from 1870 to 1973 and is partly in force and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 147 dealing with hackney

coaches was repealed by 1 & 2 Will. IV c.22. Chapter 148 dealing with excise was repealed by 55 Geo. III c.93. Chapter 150 dealing with the distillation of spirits was repealed by 1 & 2 Will. IV c.55. Chapter 151 dealing with the Paymaster-General was repealed by 57 Geo. III c.47. Chapter 155 dealing with aliens was repealed by 55 Geo. III c.54. Chapter 156 dealing with copyright was repealed in 1842 and the subject is now dealt with by the Commonwealth Copyright Act 1968. Chapter 159 dealing with harbours was repealed in 1981. Chapter 160 dealing with an annuity to the Princess of Wales was repealed in 1873. Chapter 161 dealing with an annuity to the Duke of Wellington was repealed in 1972. Chapters 162 and 165-166 deal with annuities to the successful commanders in the Peninsular war against Napoleon. Chapter 166 is of interest in this State as it is an annuity to Lord Lynedoch after whom our town of Lyndoch was named by Colonel Light. Chapter 167 dealing with appropriation, chapter 171 with customs, and chapter 172 with spirit duty, were all repealed in 1873. Chapter 163 a personal Act was repealed in 1953. Chapter 164 also a personal Act was repealed in 1893. Chapter 168 dealing with the attestation of deeds was repealed in 1873 and is dealt with in the Sixty-First Report of this Committee. Chapter 170 dealing with poor relief was repealed in 1971. Chapter 173 dealing with land tax redemption was repealed in 1963. Chapter 174 dealing with post horse duties was repealed in 1861. Chapter 175 dealing with nonresident clergymen, chapters 176 and 177 with the militia, 178 with yeomanry, 180 with unlawful combinations in Ireland, and 182 with trade with Malta, were repealed in 1873. Chapter 179 dealing with the Irish militia was repealed in 1875. Chapter 181 dealing with assaults in Ireland was repealed in 1851. Chapter 183 dealing with the excise was repealed by Geo. III c.66. Chapter 184 dealing with the accounts of Colonial revenues in Ceylon, Mauritius, Malta, Trinidad and the Cape of Good Hope, was repealed in 1873. Chapters 186 dealing with the escape of offenders in the United Kingdom, 188 with Exchequer bills, 189 with the militia, and 190 with land tax, were repealed in 1873. Chapter 186 was probably impliedly repealed by Ordinance 15 of 1849 which is an adaptation of the Imperial Statutes 11 & 12 Vict. c.42. The Ordinance 15 of 1849 was in its turn repealed by the Justices Act 1921. However for certainty chapter 186 had better be expressly repealed now. Chapter 187 dealing with depredations on the Thames was was repealed by 1 & 2 Geo. IV c.118. Accordingly of the statutes of 54 George III for 1814, chapters 44-45, 47, 49-55, 56 but with the reservation therein referred to, 57-58, 61-71, 73-85, 88-95, 97-100, 102, 105-108, 111-117, 119-121, 123-125, 127-128, 130, 131 so far as unrepealed, 132-144, 149, 152-154, 156-167, 169-182, 184, 186 and 188-190 remain to be repealed in South Australia today.

Chapter 51 dealing with county rates was repealed by statutes from 1852 to 1939. Chapters 52 dealing with the customs, 53 with duties on property, 63 with excise, and 64 with the East India Company, were repealed in 1873. Chapter 54 dealing with aliens was repealed in 1873 and is dealt with in the Sixty-Fifth Report of this Committee. III c.64 and the balance by statutes from 1873 to 1921. Chapter 68 dealing with highways was repealed by 5 & 6 Will. IV c.50. Chapter 69 dealing with madhouses in Scotland was repealed in 1857. Chapter 70 dealing with the records of the Court of Session was repealed by statutes of 1873 and 1937. Chapter 71 dealing with hawkers in Scotland was repealed in 1888. Chapter 72 dealing with Glamorganshire election was repealed in 1890. Chapters 73 dealing with lotteries, 75 with the discovery of longitude at sea, 76 and 77 with the militia, 85 with the enlistment of foreigners, and 86 with imports, were repealed in 1873. Chapter 91 dealing with criminal costs in Ireland is still in force. Chapter 92 dealing with prisons in Ireland was repealed by 7 Geo. IV c.74. Chapter 93 dealing with silk, chapter 97 with the commissary Court of Edinburgh, chapter 98 with elections in Ireland, and chapter 102 with leather duties, were repealed in 1873. Chapter 94 dealing with herring fishery in Scotland was repealed in 1981. Chapters 103, 145

and 153 dealing with postage were repealed in 1837. Chapter 106 dealing with duties on paper hanging was repealed by 5 Geo. IV c.55. Chapter 107 dealing with Richmond Lunatic Asylum was repealed by 11 Geo. IV & 1 Will. IV c.22. Chapters 108 dealing with mutiny, 113 with glass duty, 117 with imports, 126 with allowances to foreign officers, 130 with payment to forces abroad, 131 with half pay of officers, and 132 with trade in spirits, were repealed in 1873.

Chapter 109 dealing with prisoners in Scotland was repealed in 1950. Chapters 110 dealing with duties on sweets, 129 with drawbacks, 135, 163 and 181 with customs, 169 with the national debt, 177 with the manufacture of sweets, and 179 with salt duty, were repealed in 1861. The Tasmanian Church of England Act regards it as an Act which ought to be kept in force in Tasmania and having looked at it, some sections of it would appear to be still applicable in South Australia. Accordingly it should be repealed here with a reservation in favour of the Church of England. Chapter 157 dealing with evidence in Ireland is partly repealed by statutes from 1890 to 1962 and is partly in force. Chapter 159 dealing with hackney coaches was repealed by 1 & 2 Will. IV c.22. Chapter 160 dealing with prize was repealed in 1864. Chapter 161 dealing with taxes in Scotland was repealed in 1880. Chapters 162 dealing with duties on Epsom salts, 164 with spirit duty, 165-167 with militia pay, 171 with inciting to mutiny, 173 with trade protection, 175 with coal to London, 178 with flax manufacture and 180 with exports, were repealed in 1873. Chapter 168 dealing with the militia, and chapter 196 dealing with Exchequer bills, were repealed in 1875. Chapter 170 dealing with the Paymaster-General was repealed by 57 Geo. III c.41. Chapter 172 dealing with the slave trade was repealed in 1861 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 176 dealing with duty on tiles was repealed by 7 Geo. IV c.49. Chapter 182 dealing with inland navigation in Ireland, chapter 183 with exports, chapter 187 with appropriation, 189 with allowance of duty, and 193 with trade with the United States, were repealed in 1873. Chapter 184

dealing with stamp duty was partly repealed by statutes from 1869 to 1975 and is partly in force. Chapter 186 dealing with the purchase of an estate for the Duke of Wellington was repealed in 1972. Chapters 15 and 51 dealing with commerce with the United States were repealed by 59 Geo. III c.54. Chapters 16 dealing with receivers of Crown rents, 17 and 20 with excise, 18 with duty on lead, 19 with bounty, 21 with notes and bills, 22 and 23 with the custody of the Emperor Napoleon, and 24 making provision for Princess Charlotte, were repealed in 1873. Chapters 40, 42, 47 and 48 dealing with Treasury bills, 43 with malt duty, 44 with soap duty, and 45 with the militia, were repealed in 1873. Chapter 46 dealing with the civil list audit was partly repealed by statutes from 1873 to 1981 and is partly in force. Chapter 49 dealing with county rates was repealed in 1852. Chapter 50 dealing with the sale of farming stock was partly repealed by statutes from 1873 to 1890 and is partly in force. Chapter 52 dealing with glebe land exchange was repealed in 1976. It is listed in the list of statutes relating to the Church of England in Tasmania and for the reasons we gave with regard to the last glebe statute it would

be proper to repeal it here with a reservation in favour of the Church of England. Chapters 53 relating to the national debt commissioners, 54 to Exchequer bills, 61 to lotteries, 65 to property duties, and 67 to trades by soldiers, were repealed in 1873. Chapters 55, 111 and 136 are local Acts. Chapter 56 dealing with probate duty was amended in 1981 and is still partly in force. Chapter 57 dealing with assessed taxes was repealed by 58 Geo. III c.54. Chapter 58 dealing with beer was repealed in 1885. Chapters 59 dealing with malt duties, 70 with the national debt in Ireland, 75 and 79 with rape seed duty, 77 and 85 with customs, and 86 with aliens, were repealed in 1861. Chapter 62 dealing with Dublin Harbour was repealed in 1869. Chapter 63 dealing with Millbank Penitentiary was repealed in 1843. Chapter 64 dealing with the militia was repealed in 1875. Chapter 66 dealing with assessed taxes was repealed in 1869. Chapter 68 dealing with the coinage was repealed in 1870 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 69 dealing with madder duty, 71 with Crown rents, 72 with yeomanry, and 76 with exports, were repealed in 1873. Chapter 73 dealing with stealing property from mines was repealed in 1861 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 74 dealing with land at Sheerness was partly repealed by 1 & 2 Geo. IV c.107 and is partly in force. Chapters 78 and 103 dealing with paper duties were repealed in 1839. Chapter 80 dealing with naval stores was repealed in 1862. Chapter 82 dealing with delegates hearing causes in Vice-Admiralty in the colonies was repealed in 1890. Normally it would be caught by the Colonial Laws Validity Act but the provisions are now superseded by the Colonial Courts of Admiralty Act 53 & 54 Vict. c.27 which is in force in South Australia, and chapter 82 can therefore be repealed. Chapter 83 dealing with passenger traffic in Newfoundland, and chapter 114 dealing with shipping, were repealed by 4 Geo. IV c.84. Chapter 84 dealing with Holyhead harbour was repealed by 4 Geo. IV c.74. Chapter 87 dealing with the grand jury in Ireland is in force. Chapter 88 dealing with recovery of tenements in Ireland was repealed by statutes of 1851 and 1860. Chapter 90 dealing with the militia, chapter 92 with exports, and chapter 95 a private Act, were repealed in 1873. Chapters 94 dealing with salt duty, and 97 dealing with unclaimed dividends, were repealed in 1861. Chapter 96 dealing with the Bank of England was repealed in 1973. Chapter 98 dealing with consolidated fund was partly repealed by statutes from 1873 to 1973 and is partly in force. Chapter 99 dealing with the British Museum was repealed in 1963. Chapter 100 dealing with habeas corpus was partly repealed by statutes of 1888 and 1890 and 1981 and is partly still in force. It was held to be in force in New South Wales in Ex parte West (1861) Legge's Reports 1475. It is a constitutional statute and will be dealt with in our report on constitutional statutes. Chapter 101 dealing with naval officers on half pay was repealed by 11 Geo. IV & 1 Will. IV c.20. Chapters 102 dealing with insolvent debtors, 105-106 and 111 with spirits, 107 with inventories in Scotland, 108 with excise, and 109 with exports, were repealed in 1873. Chapter 104 dealing with excise, and chapter 116 dealing with prisoners for debt, were repealed in 1890. Chapter 110 dealing with tanners was repealed by 3 Geo. IV c.83. Chapter 112 dealing with distillation of spirits was repealed by 1 & 2 Will. IV c.55. Chapters 113 dealing with beer licences, 118 with oil duty, 119 with mutiny, 127 with exports, were repealed in 1861. Chapter 117 dealing with the custody of insane persons charged with offences was repealed by 9 Geo. IV c.40. Chapter 120 dealing with Irish prisoners is still in force. Chapters 121 dealing with the militia, 122 with the Irish Court of Exchequer, 123 with residence on benefices, 124 with coals to London, and 126 with insolvent debtors in Ireland, were repealed in 1873. Chapter 125 dealing with malicious damage in Scotland was repealed in 1973. Chapter 128 dealing with paving Marylebone Park was repealed

by 5 Geo. IV c.100. Chapters 129 and 139 relating to the poor law were repealed in 1927. Chapter 130 dealing with night poaching was repealed by 57 Geo. III c.90. Chapter 131 dealing with Acts continuance was repealed in 1873. Chapter 132 dealing with Windsor Forest was repealed in 1971. Accordingly of the statutes of 1816, chapters 1-4, 6-8, 10-14, 16-26, 28-34, 36, 38, 39-50, 52 but with the reservation therein referred to, 53-56, 58-67, 69-73, 74 so far as unrepealed, 75-82, 85-90, 92, 94-99, 102-109, 111-113, 115-116, 118-127, 129, 131-133, 135-137, 139 and 141-142 remain to be repealed in South Australia today.

Chapters 21 dealing with arms in Ireland, 23 with imports, and 26 with national debt commissioners, were repealed in 1873. Chapter 22 dealing with superintending magistrates in Ireland was repealed by 6 & 7 Will. IV c.13. Chapters 34, 54 and 98 are local Acts, 108 is a local Act which was amended in 1980, and 129 is a local Act. Chapter 125 dealing with house tax was repealed in 1924. Chapters 27 dealing with buckwheat duty, 35 with mutiny, 38 with Acts continuance, and 40 with distillation, were repealed in 1873. Chapter 100 dealing with land tax redemption was partly repealed by statutes of 1888 and 1963 and is partly in force. IV c.73 and by statutes from 1873 to 1967 and is still partly in force, and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 9 dealing with newspaper duty was repealed in 1869. Accordingly of the statutes of 60 George III and 1 George IV for 1819, chapters 2, 3, 7 and 9 remain to be repealed in South Australia today.

Statutes 60 Geo. III & 1 Geo. IV (1820) cc. 10-14:

Chapter 10 dealing with indemnity was repealed in 1871. Chapter 11 dealing with parliamentary elections in Ireland was repealed in 1948. Chapters 12 and 13 dealing with Acts continuance, and 14 with commitments outside a country, were all repealed in 1873. Accordingly chapters 10-14 of the statute of 60 George III and 1 George IV for 1820 should be repealed in South Australia now.

Statutes 1 Geo. IV (1820) cc. 1-119:

Chapters I dealing with the civil list, 2 with the South Sea Company. and 3 with insolvent debtors, were repealed in 1873. Chapter 4 dealing with stage coaches in Scotland was repealed in 1958. Chapter 5 dealing with transfer of stock in Ireland was partly repealed by statutes of 1873 and 1890 and is partly in force there. Chapter 6 dealing with glebe exchange was repealed in 1976. Chapters 7, 8 and 80 dealing with the customs, 34 and 61 with imports, and 43 with smuggling, were repealed by 6 Geo. IV c.105. Chapters 9 dealing with shipping, 22 with national debt and 26 with the coasting trade, were repealed in 1861. Chapters 10 dealing with supply, 11 with trade with the Cape of Good Hope, 15 with flax, and 16 with glass duty, were repealed in 1873. Chapters 12 dealing with imports from Jamaica, and 33 with imports from Barbados, were repealed by 3 Geo. IV c.44. Chapters 13, 17 and 23 dealing with the national debt, were repealed in 1870. Chapter 14 dealing with gold plate export was repealed in 1890. Chapters 18 dealing with aliens, 19 with mutiny, 20 with marine mutiny, 24 with Acts continuance, and 25 with sail cloth, were repealed in 1873. Chapter 21 dealing with the trial of actions in Middlesex was repealed in 1879. Chapter 27 dealing with clerks of the peace in Ireland was repealed in 1877. Chapter 28 dealing with coroner's fees in Ireland was repealed in 1846. Chapters 29, 49, 70, 106 and 113 are local Acts. Chapter 30 which is a personal Act was repealed in 1874. Chapters 31 dealing with Exchequer bills, 33 with the Greenland whale fishery, 38 with quartering soldiers, and 39 with credit in Ireland, were repealed in 1873. Chapter 35 dealing with the Court of Exchequer was repealed in 1861 and is dealt with in the Sixty-First Report of this Committee. Chapter 36 dealing with poor law appeals was repealed in 1950. Chapter 37 dealing with special constables was repealed in 1873 and is dealt with in the Fifty-Eighth Report of this Committee. Chapter 40 dealing with tithes was repealed in 1861. Chapter 41 dealing with the recovery of tenements in Ireland was repealed by statutes from 1851 to 1860. Chapter 42 dealing with a Crown debt was repealed in 1950. Chapters 44 dealing with a consolidated fund, 46 with Treasury bills, 47 with arms in Ireland, and 48 with yeomanry, were repealed in 1873. Chapter 45 dealing with customs was repealed by 4 Geo. IV c.26. Chapters 50 dealing with negro slaves, 51 with Newfoundland, 52 and 53 with imports, and 54 with coals to London, were repealed in 1873. Chapter 55 dealing with the Court of King's Bench was repealed in 1879. It gives power to judges to sit in vacation and that no doubt is the origin of the

power which we have and exercise in the Supreme Court today. Accordingly the Act should be repealed but the relevant provision should be put in the Supreme Court Act. Chapter 56 dealing with the criminal law was repealed by 7 & 8 Geo. IV c.27 and 9 Geo. IV c.53. Chapter 57 dealing with female convicts was repealed in 1948 and is dealt with in the Fifty-Ninth Report of this Committee. Chapter 58 dealing with paper duties was repealed in 1839. Chapters 59 dealing with coffee, 62 with duties in New South Wales following the comments of Bentham, and 63 with bounties, were repealed in 1873. Chapter 60 dealing with public works loans was repealed in 1875. Chapters 64, 65, 66 and 67 dealing with Acts continuance and 71 with Crown lands, were repealed in 1873. Chapter 68 dealing with the Court of Exchequer in Ireland was repealed by statutes from 1873 to 1953. Chapter 69 dealing with Dunleary (now spelt Dun Laoghaire) Harbour was repealed in 1869. Chapter 72 dealing with lotteries was repealed in 1861 and is dealt with in the Sixty-Eighth Report of this Committee. Chapter 73 dealing with assessed taxes was repealed in 1869. Chapter 74, 76 and 77 dealing with the spirit trade, 79 with brewers, 81 with public works loans, and 86 with militia pay, were repealed in 1873. Chapters 75 dealing with tobacco duty, 78 dealing with spirit licences in Ireland, and 99 with the East India Company, were repealed in 1861. Chapters 82 dealing with Irish fisheries, and 103 dealing with British fisheries, were repealed in 1868. Chapter 83 dealing with the English Savings Bank was repealed by 9 Geo. IV c.92. Chapter 83 dealing with army prize money was repealed by 2 & 3 Will. IV c.53. Chapter 85 dealing with naval prize was repealed in 1865. Chapter 87 provides a more easy and simplified method of recovering premises by a landlord. It was repealed in England in 1861. We think that the matter is now sufficiently dealt with cumulatively by the Residential Tenancies Act, the ejectment provisions of the Local Courts Act, and Part XVII of the Real Property Act, but we refer the matter to you in case it needs consideration. Chapter 88 dealing with post horse duties was repealed by 4 Geo. IV c.62. Chapters 89 dealing with postage and 107 dealing with the estate of the Master of the Rolls, were repealed in 1837. Chapter 90 dealing with offences at sea was repealed by 9 Geo. IV c.31 and again for good measure in 1967. Chapter 91 dealing with the Royal marines was repealed by 2 & 3 Will. IV c.40. Chapter 92 dealing with forgery of bank notes in Scotland was repealed in 1981. Chapter 93 dealing with artificers' wages was repealed in 1873. It was a simplified way of obtaining wages for servants. No doubt we inherited it in 1836 but we think that the matter is now covered by the relevant provisions of the Industrial Conciliation and Arbitration Act. Chapter 94 dealing with the census, chapter 95 dealing with turnpike road trusts, chapter 96 dealing with militia pay, and chapter 97 dealing with insolvent debtors in Ireland, were all repealed in 1873. Chapter 98 dealing with lunatic asylums in Ireland was repealed by 1 & 2 Geo. IV c.33. Chapter 100 dealing with the City of London militia was partly repealed by statutes from 1890 to 1969 and is partly in force. Chapter 101 providing for the taking of the evidence of witnesses in India for divorce bills before Parliament was repealed in 1950. Chapter 102 dealing with stealing property from mines was repealed in 1861 and is dealt with in the Fifty-Ninth Report of this Committee. Chapters 104 dealing with barracks, 105 with aliens, 110 with Exchequer bills, and 111 with appropriation, were repealed in 1873. Chapter 108 dealing with annuities to the Royal family was partly repealed in 1873 and is partly in force. Chapter 109 dealing with pensions to George III's servants was repealed in 1874. Chapter 112 dealing with Portpatrick harbour was repealed in 1873. Chapter 114 dealing with Caversham rectory was repealed in 1950. Chapters 115 and 116 dealing with capital punishment were respectively repealed in 1861 and 1873 and are dealt with in the Fifty-Ninth Report of this Committee. Chapter

117 dealing with larceny committed in shops was repealed by 7 & 8 Geo. IV c.27. Chapter 118 dealing with malt duty was repealed in 1861. Chapter 119 dealing with insolvent debts was repealed by 7 Geo. IV c.57. Accordingly of the statutes of 1 George IV for 1820, chapters 1-6, 9-11, 13-31, 33, 35-36, 38-42, 44, 46-54, 55 but only after it has been put in the Supreme Court Act, 58-60, 62-71, 72-79, 81-82, 85-86, 87 after it has been considered by you, 89, 92-97, 99-101, 103-114 and 118 remain to be repealed in South Australia today.
